

# Parent-Teen Driving Contract

To encourage safety and continued driving skills, this contract is here to keep both the teen driver and guardian(s) accountable.

Please read each driving rule with the teen driver and discuss. After you discuss each rule, have your teen initial it to show they understand. At the end of the contract, sign and date it to indicate you both agree to the rules and consequences you discussed.

## Teen Driving Rules

### Speed Limits:
